2. FILEKEEPERS

<u>Wanganui</u>: Mr A. J. Bannister resigned last year from the position of Wanganui Filekeeper. Action is being taken to appoint a new filekeeper.

East Coast: It is hoped shortly to appoint a filekeeper in this area, which is at present being served on a caretaker basis by the Bay of Plenty filekeeper. It is expected that appointment of a filekeeper will at last result in some recording in this important region.

3. SITE PROTECTION

Council believes that much can be done at a local level to secure better protection for sites, and in some cases a great deal has been achieved already. An article by the Central Filekeeper on "Town and Country Planning and the Archaeologist" appeared in the <u>Newsletter</u>, vol. 13, No. 1. It is hoped that this article will assist members and affiliated societies to obtain more effective protection of sites, and will also help to dispel the widely held and wrong idea that there is no legislation enabling site protection to be achieved. It is pleasing to report that the site recording handbook is at last with the printers and should be ready for sale in about two months.

I would like to thank all those people who have helped me in different ways to compile this handbook. Their contributions have helped to ensure that it will be a valuable aid to recording.

5. FUTURE OF THE SITE RECORDING SCHEME

In the past the scheme has been widely used for research, and has been well supported by both amateur and professional archaeologists. The result has been a considerable amount of work by dedicated and hard-working recorders and filekeepers. It is therefore disheartening to discover that an increasing amount of recording is taking place under the auspices of Universities and Training Colleges outside the framework of the scheme.

Although Council believes that the scheme is important to New Zealand archaeology, it will be greatly weakened if it is not used by those who are in the best position to ensure its health and viability. If people in this position do not feel that the scheme is working as it should, they should state to Council what they think the deficiencies are and how they could be remedied.
