#### **NZAA** Council

At the 24 February meeting of the New Zealand Archaeological Association Council the following matters were discussed under General Business:

#### 2007 conference

Lynda Walter reported that all was going well and approximately 20 pre-registrations had already been received. Conference dinner would be held at the conference venue, the Heritage Hotel, Hanmer. Richard Walter reported that he had received offers of approximately 30 papers already and was confident of a full and interesting programme.

## Digital strategy

An expression of interest for funding from Internal Affairs' Community Partnership Fund to start moving towards digitising the present Site Recording Scheme paper records has been submitted. We will be advised early March if this has passed the first round. If so, a developed application will need to be prepared in April.

# NZAA/DoC/NZHPT working party

A 23 Feb meeting of the NZAA/DoC/NZHPT working party agreed a final version of the interim MOU, and made significant progress on the long-term agreement.

### New Zealand Archaeological Association Pubic Archaeology Award

#### Call for Nominations 2007

The Public Archaeology Award is presented every second year to recognise outstanding efforts in public archaeology.

The award is open to members of NZAA and to the wider community, including individuals, groups and organisations (for example territorial authorities, iwi) and members of other scientific disciplines.

The following factors are taken into account:

- Contribution to the identification, protection and preservation of archaeological sites;
- contribution to the enhancement of public awareness and enjoyment of, and education about, archaeological sites or archaeology in general;

- contribution to the strengthening of the relationship between the archaeological; community and Maori
- any other relevant information.

## The NZAA Site Recording Scheme Upgrade Project

Fieldwork in Whangarei District has been completed and James Robinson is working on the final report for the district. James is also carrying out the paper-based review of the rest of the Northland file district, which is due for completion by the end of June.

Phil Latham has commenced fieldwork in the Rodney District. There has so far been a high rate of refusal of property access in the Rodney District. which is disappointing. Fieldwork in Waitakere City area is nearing completion. Auckland city is not participating in the project, and Manukau City has not decided what form its participation will take. Fieldwork in Franklin District should be getting underway in April.

In the Waikato Region, fieldwork in the Hauraki District has been completed. Next up are Waikato, Waipa and Otorohanga Districts throughout this year. John Coster is still working on the paper-based review for the whole Waikato Region, so please let John know if you have done any recent updates that have not made it into the file yet.

Fieldwork in the Whakatane District is just beginning, with completion due by the end of June. For the rest of the region, the updated data has been loaded to the database service and is available to councils.

All possible fieldwork in the Hawkes Bay Region has been completed. The data entry and final report for Napier City and Hastings District is currently being prepared by CFG Heritage Ltd. No further work is possible in the region unless the non-participating councils; Hawkes Bay Regional Council, Central Hawkes Bay and Wairoa District Councils have a change of heart.

The final report for New Plymouth District has been completed and the updated data is available. The final report for South Taranaki District is in preparation. Fieldwork in the Wanganui District has been partially completed, with Phil Latham due to finish this off during April. Fieldwork in the Ruapehu District will be commencing within the next two months. Ivan Bruce has completed fieldwork in the Horowhenua District and the final report is being prepared.

In the Wellington Region, fieldwork has been completed in the districts west of the Rimutaka Ranges with most final reports having also been completed. James Robinson has almost completed fieldwork in the South Wairarapa District and will be moving on to Carterton and Masterton in the next few months.

Moving further south, fieldwork in Dunedin City has been completed on the Otago Peninsula by Phil Latham, and will be expanded to the rest of the district over the next few months. Queenstown-Lakes and Waitaki Districts have now both provided funding for a paper-based review which will be completed prior to June this year. Richard Walter and Chris Jacomb will commence fieldwork in the Clutha District during April.

We are still awaiting the outcome of a funding bid to the Ministry for Culture & Heritage in order to finish off project work in the 07/08 financial year. The result should be known in April.
