 - An archaeological site, R11/1394, was excavated prior to development of an industrial subdivision. Evidence was found of storage pits, cooking, a house and stone tool manufacture and use. Occupation was placed in the 16th century AD and the site has been interpreted as a

small undefended settlement typical of this part of South Auckland at that time with small hamlets scattered throughout the volcanic areas surrounding the cones of Otahuhu and Te Apunga O Tainui, although the presence of moa bone and dentalium shell is unusual in an Auckland site of this age.
