## RECENT REPORTS

Felgate, M. 1996. Cultural Heritage Inventory: A Base Inventory for Waitakere City. ARC Environment Technical Publication 73, Auckland Regional Council. 230 pp plus maps.

A detailed review of the archaeology of Waitakere City, with summaries of the results of site recording and excavation work and a full bibliography. Previous volumes have covered North Shore City, Manukau City, Franklin District, and matters maritime.

Fletcher, P. 1996. Archaeological survey of Te Kohatu Block area Western Taupo. Report for Carter Holt Harvey and landowners. 59 pp plus SRFs

More than 80 sites, all dating to before 1900, recorded. About one third are rock shelters, some with rock art. Report also contains a summary of oral traditions and 19th century history.

Forbes, S. 1996. Te Waipunahau archaeological survey. Report to Horowhenua Lake Trustees. 99 pp.

A survey of archaeological sites around Te Waipunahau (Lake Horowhenua). Includes sections on landscape, resources, traditions, and recommendations on management.

Forbes, S. and W. Gumbley 1996. Ngati Pahauwera Rohe archaeological survey. 50 pp.

Selected areas of Ngati Pahauwera Rohe in Hawkes Bay surveyed and some 50 sites, including 5 pa and numerous pit sites, recorded.

Fredericksen, C., D. Kahotea and M. Felgate 1996. An archaeological survey of Papamoa coastal zone, Tauranga District. Report to Tauranga District and NZ Historic Places Trust. 40 pp plus SRFs.

Survey of area undergoing rapid residential development. 77 new sites, mostly midden, recorded.

Grouden, V. 1996. Archaeological field survey R.H. & M.K. Crail property Tiniroto Road, Gisborne. Report to P. Ericson. 8 pp plus SRFs.

Three previously-recorded sites re-visited.

Hamel, J. 1996. The Arrow, the Billy and Brackens Gully: gold mining on Glencoe. Report to Department of Conservation, Otago Conservancy. 86 pp.

Gold mining was undertaken between the 1860s and 1930s leaving a variety of remains including stone huts, tailings, races and pipelines, and prospecting pits.

Ross, S. and R. Foster 1996. Cultural Heritage Inventory. The state and condition of archaeological sites in the Auckland Region. Report to Auckland Regional Council. 34 pp plus appendices.

A study of state of current information about the condition of sites in Auckland region, and need for upgrading of existing information.
