## **RECENT REPORTS**

Corbett, P.D. 1997. World War II Defences At Stony Batter (Waiheke Island) and Whangaparoa. 9.2-inch Counter-bombardment Batteries A-1 and A-2. Department of Conservation, Auckland Conservancy Historic Resource Series No. 14. 96 pp.

A detailed narrative of the planning and construction of the two 9.2-inch coastal defence batteries at Auckland during World War II.

Fletcher, P. 1996. Archaeological survey of Mt Pohaturoa. Unpublished report to Carter Holt Harvey. 55 pp.

A detailed examination of Mt Pohaturoa and recording of 31 house sites (part of pa U17/1) and other features, including a rockshelter (U17/4).

Forbes, S. 1997. Archaeological survey Upper Manawatu River. Report for Te Kaunihera Kaumatua o Rangitane Ki Manawatu and Palmerston North City Council. 50 pp.

An examination of available data on settlement along the upper Manawatu River, between the Oroua and Pohangina tributaries. An archaeologically little known area.

Grouden, V. 1997. Archaeological field survey. Puketarewa (or Pukutarewa), Te Hua and Mangamaia. Proposed Forestry Blocks. Unpublished report to Mangatu Blocks Incorporation. 12 pp. One site recorded in areas proposed for afforestation in one part of the East Coast.

Historic Resources Management Services. 1997. Awakeri Conservation area and Latham's Hill Track Covenant Areas. Unpublished report to Department of Conservation. 33 pp.

Inspection of archaeological sites, and accompanying historical research, to assist management strategy for DoC-controlled areas near Whakatane.

Historic Resource Management Services 1997. Assessment of archaeological value ... site number U15/202 - Okahu Pa. 15 pp.

Inspection of site U15/202 and recommendations for minimising damage from harvesting of trees and future management.

Jackman and Black Archaeology 1996. Archaeological Assessment report: Nuhaka-Rakau Block. Report to P.F. Olsen & Co. 28 pp.

Survey of two forestry blocks east of Wairoa.

Lawlor, I. 1997. Inspection of Motukoruenga and Motukoranga Islands, Whitianga, Coromandel Peninsula, 28 January 1995. Department of Conservation, Conservation Advisory Notes No. 148. 10 pp.

Archaeological evidence was found on both islands and included midden and terrace sites along with, on Motukoranga I., a pa site.

Petchey, P. 1997. Kirtleburn Hotel, Kawarau Gorge, Central Otago. Report on the stripping and excavation of archaeological sites \$133/511 and \$133/512. Report for Transit New Zealand. 34 pp.

A three day investigation of a hotel and stockyards site of late 1870s which was being affected by re-alignment work on the highway. The position of the hotel was determined and metal, ceramic, glass, and domestic artefacts were recovered.

Shepherd, M., B. McFadgen, H. Betts and D. Sutton 1997. Formation, Landforms and Palaeoenvironment of Matakana Island and Implications for Archaeology. Department of Conservation, Science and Research Series No. 102. 99 pp.

Matakana Island has undergone major environmental change throughout its history. Since 600 cal BP natural changes have been augmented by human impact. Middens are common and gardening was probably widespread.
