Unpublished report to Tauranga District Council. 88pp. [Continuation of survey of Papamoa lowlands, an area undergoing rapid residential development. Survey extended the area covered to the Kaituna River Mouth.]
- Jones, K.L. 2000. Native grasslands and the stabilization of earthwork archaeological sites on the middle Missouri River, North Dakota. *Conservation and Management of Archaeological Sites* 4:139-150.
- Leathwick, J.R. 2000. Predictive models of archaeological site distributions in New Zealand. *Science & Research Internal Report 181*, Department of Conservation, 12 p. [Based on an analysis of the distribution of recorded pa and pit sites, paper identifies environmental correlates and predicts and maps the probability of occurrence of these sites. Highest probability in high insolation, warm, summer-dry locations, mostly in northern and eastern NZ, but also associated with certain rock types, coast and water bodies.]

- Williams, A., Tupara, N. 2000. Rock art conservation survey, Tongariro/Taupo Conservancy. *Conservation Advisory Science Notes 315*, Department of Conservation, 10 p. [Tongariro/Taupo Conservancy contains a large number of recorded rock art sites. This report summarises a project undertaken to assess origin, condition, threats, and conservation needs of a selected group of rock art sites.]
