

## **JPA PUBLICATION GRANT**

### *Summary*

Aotearoa New Zealand, along with many other countries, has long had a problem with archaeological “grey literature”, particularly in the consultant archaeological community. It is hoped that by providing financial support for publication in the *Journal of Pacific Archaeology*, as well as the community prestige of an award like this, those working in archaeology outside of academic institutions will be encouraged to consider the research potential of their projects and disseminate that work through research publication.

This grant is intended to support and encourage the publication of archaeological projects in Aotearoa New Zealand, particularly by those – i.e. consultants – who would otherwise be unable to dedicate the time required to write up their work for publication.

The grant will be an annual award, granted by the New Zealand Archaeological Association, in order to cover expenses during the process of writing, submitting and reviewing a peer-reviewed article on Aotearoa New Zealand archaeology (articles are of 4000-8000 words; see <https://pacificarchaeology.org/index.php/journal/about/submissions#authorGuidelines>). It will be available to archaeological consultants and researchers who are not employed by or enrolled with existing research institutions in Aotearoa New Zealand.

The dissemination of archaeological information and the encouragement of archaeological research are both objectives of the NZAA (c and e) and fit easily within the goal of sharing Aotearoa New Zealand’s past, as outlined in the 2020-2025 Strategic Plan.

### *Eligibility*

Applications will be open to Aotearoa New Zealand based archaeological consultants and/or archaeological researchers who are *not* employed by Aotearoa New Zealand universities or recipients of research grants, such as Marsden Fund grants or Royal Society Fellowships, at the time of application. Applicants must be NZAA members at the time of application.

The subject of the proposed article must be primarily related to Aotearoa New Zealand archaeology and the applicant must be intending to submit the paper to the *Journal of Pacific Archaeology*. The work reported on must primarily be the result of consultancy work, such as an archaeological authority or a heritage assessment.

The final report on the work must have been completed and submitted. In exceptional circumstances, applications where the report has not been completed will be considered.

### *Application*

Application for the award will require a 250-word abstract on the proposed research paper, plus proof of eligibility, including when the final report was submitted. Applications relating to sites or archaeology of interest to Māori must include a letter of support from mana whenua. Papers that are jointly authored by an archaeologist and mana whenua are encouraged. Where practicable, applications should also be accompanied by a letter of support from the archaeological authority holder and/or client. Applications for co-authored papers will be accepted, but the total sum paid out will remain the same.

### *Duration*

The grant will be awarded once a year.

As the allocation of the grant is intended to facilitate publication, proof of submission to a journal must be provided within twelve months of the award being issued.

### *Budget*

A maximum of \$3000 will be available to the recipient.

### *Implementation*

Applications for the grant will be required by 30 September 2022, and the successful applicant will be announced at the NZAA conference in Dunedin. Applications will be assessed by a panel of three people: a former editor of the *Journal for Pacific Archaeology*, a member of the New Zealand Archaeological Association Council and a member of the Kaupapa Māori Advisory Group. The decision on which application will receive the grant should be made by consensus. If consensus is not possible, the matter shall be decided by vote.

Allocation of the monetary compensation will be overseen by the NZAA treasurer. This money will be paid to the recipient as two lump sums, one at the time of the award and one at the time of submission. Payment will be upon receipt of invoice. It is intended to allow recipients to take time away from paid projects or employment in order to write up a paper, but it could conceivably be used for other research expenses, such as radiocarbon dates or other analyses, as long as a paper is submitted within twelve months of the award.

If the final paper is not accepted for publication in *JPA*, other journals may be approached for publication, in consultation with the NZAA Council.

If the terms of the grant are not met, the recipient will be required to refund the monies to NZAA.
